# JOURNAL OF THE CONSTITUTIONAL CONVENTION

#### Providence, Rhode Island

June 12, 1967 Third Session

The Convention was called to order by Mr. Dennis J. Roberts, Chairman, at 2:56 p.m.

The roll of delegates was called: there were 67 present and 32 absent.

Absentees were: Messrs. Appolonia, Baccari, Mmes. Barber, Castiglia, Messrs. Crandall, Cunningham, DiLuglio, Dodge, Fanning of Cumberland, Fontaine, Gallagher, Gallogly, Gammino, Gates, Giguere, Jordan, Mrs. Lacroix, Messrs. LaFrance, Martin, McCabe, McKinnon, Merolla, Moon, Mulligan, Murphy of Warren, Murphy of Coventry, Parrillo, Mrs. Pulner, Messrs. SaoBento, Steere, Toolin and Vacca.

The names of the absentees were called.

On motion of Mr. Dolbashian, seconded by Messrs. Cochran and Kagan, Ernest A. Foster, was elected secretary pro tem in the absence of the secretary of the convention unanimously.

#### GENERAL ORDERS

Mr. Dolbashian, seconded by Mr. Wexler, moved that the Convention resolve into a Committee of the Whole upon the General Orders of the Day.

The motion prevailed on a voice vote.

Upon the rising of the Committee of the Whole, the Chairman again called the convention to order.

At 4:13 p.m. on motion of Mr. Wexler, seconded by Mr. DeCiantis, the Convention adjourned to meet on Monday, June 19, 1967, at 1:30 p.m. in the Chamber of the House of Representatives at the State House, on a voice vote.

Journal of the Committee of the Whole

June 12, 1967 Third Session

Upon the resolving of the Convention into a Committee of the Whole, the Chairman called the Committee of the Whole to order.

#### GENERAL ORDERS

The Committee of the Whole proceeded to consideration of the document by sections.

The preamble was read.

On motion of Mr. Wexler, seconded by Mr. Dolbashian, the Committee of the Whole recommended adoption of the Preamble, on a division vote 54 delegates voting in the affirmative and 0 delegates voting in the negative.

The introductory paragraph and section 1 of Article I was read.

On motion of Mr. Wexler, seconded by Mr. Dolbashian, the Committee of the Whole recommended adoption of the introductory paragraph and section 1 of Article I, on a division vote 57 delegates voting in the affirmative and 0 delegates voting in the negative.

Section 2 of Article I was read.

On motion of Mr. Wexler, seconded by Messrs. Dolbashian and Wrenn, the Committee of the Whole recommended adoption of the section, on a division vote 52 delegates voting in the affirmative and 0 delegates voting in the negative.

Section 3 of Article I was read.

At 3:18 p.m. the Chairman yielded the rostrum to David D. Warren, 1st Vice Chairman.

" I move to amend Article I, Section 6, to read as follows:

"The right of the people to be secure in their persons, papers and possessions, against unreasonable searches and seizures, shall not be violated; and no warrant shall issue, but on complaint in writing, upon probable cause, supported by oath or affirmation, and describing as nearly as may be, the place to be searched, and the persons or things to be seized."
