JOURNAL OF THE CONSTITUTIONAL CONVENTION

Providence, Rhode Island

April 11, 1966

The Convention was called to order by Mr. Dennis J. Roberts, Chairman at 1:40 P.M.

INVOCATION

The Chairman presented Canon Loring William Chadwick, Canon Pastor of the Cathedral of St. John, Providence, for the purpose of giving the Invocation. The Invocation was given.

The roll of delegates was called; there were 78 present and 22 absent.

Absentees were Mrs. Barber, Messrs. Champion, Dodge, Gallagher, Gammino, Gmelin, Geoffroy, Giguere, Jordan, Mmes. Lacroix, Lambros, Messrs. Martin, McCabe, Merolla, Moon, Mulligan, Murphy of Coventry, Prince, Stapleton, Toolin, Mrs. Webster and Mr. Willey.

The names of the absentees were called.

On a motion of Mr. Wexler, seconded by Mr. Cochran, the reading of the Journal of the previous day was dispensed, on a voice vote.

REPORTS OF STANDING COMMITTEES

Mr. Murphy of Tiverton, for the Committee on Public Information, presented a report of the progress of the committee.

Mr. DiLuglio, for the Committee on the Legislative Department, reported back that, after a duly advertised public hearing was held thereon, by a vote of 8 to 0, the Committee recommended adoption of the following proposal:

Proposal No. 36 "Article XI Of Impeachments"

The proposal and report were accepted, referred to the Committee of the Whole and placed on the General Orders.

Mr. DiLuglio, for the Committee on the Legislative Department, reported back that, after a duly advertised public hearing was held thereon, by a vote of 8 to 0, the Committee did not recommend the following proposal:

Mr. Coleman announced that the Committee on Local Government would meet at the rising of the Convention.

Mrs. Foster announced that the Committee on Resolutions would meet at the rising of the Convention.

On a motion of Mr. Cochran, the delegates extended a rising vote of apprecaition to Canon Loring William Chadwick for his kindness in giving the Invocation.

COMMUNICATIONS

The Chairman announced receipt of two communications favoring retention in the Constitution of the ban on lotteries.

The Chairman announced receipt of a communication transmitting a resolution of the Rhode Island State Circle, Daughters of Isabella, supporting retention of the lottery prohibition in the Constitution.

The communications were placed on file.

The Chairman announced receipt of the following proposals:

Proposal No. 200, offered by Mr. Murphy of Warren, entitled "Term of General Officers."

The proposal was read by title and referred to the Committee on Elections and Right to Vote.

Proposal No. 201, offered by Mr. Murphy of Warren, entitled "Term of Members of the Senate."

The proposal was read by title and referred to the Committee on Elections and Right to Vote.

Proposal No. 202, offered by Mr. Murphy of Warren, entitled "Term of Members of the House of Representatives."

The proposal was read by title and referred to the Committee on Elections and Right to Vote.

Proposal No. 203, offered by Mr. Murphy of Warren, entitled "Election of General Officers."

The proposal was read by title and referred to the Committee on Elections and Right to Vote.

Proposal No. 204, offered by Mr. Murphy of Warren, entitled "Term of Office of Senators."

The proposal was read by title and referred to the Committee on Elections and Right to Vote.

Proposal No. 205, offered by Mr. Murphy of Warren, entitled "Term of Office of Representatives."

The proposal was read by title and referred to the Committee on Elections and Right to Vote.

MOTIONS AND RESOLUTIONS

Mr. Cannon, seconded by Messrs. Wexler, Cochran, Cooney, Foster and Vacca, moved that the Convention approve the appointment of Mr. Francis P. O'Donnell to the Committee on Judiciary and to the Committee on the Administration of the Convention which the Chairman submitted at the Convention session of March 5, 1966.

The motion prevailed on a voice vote.

REPORT OF THE COMMITTEE OF THE WHOLE

The Chairman announced that he would present the report of the Committee of the Whole for March 28, 1966, a copy of which was on the desk of each delegate.

On a motion of Mr. Wexler, seconded by Mr. Manning, reading of the report was dispensed and the Convention proceeded to act thereon, on a voice vote.

The Chairman, as Chairman of the Committee of the Whole on March 28, 1966 presented a report of the Committee of the Whole to the Convention and action was taken thereon as follows:

"The Committee of the Whole meeting on March 28, 1966, considered Proposal No. 142, "Of the Legislative Power."

"The Committee on the Legislative Department did not recommend the adoption of the proposal. On a division vote a motion to recommend adoption of the proposal did not prevail."

On a division vote the motion prevailed, 53 delegates voting in the affirmative and 0 delegates voting in the negative.

Also, "The Committee considered Proposal No. 80, "Of Qualifications for Office."

"The Committee on Elections and Right to Vote did not recommend the adoption. On a division vote a motion to recommend rejection of the proposal prevailed."

Mr. Kagan, seconded by Messrs. Cote, Bizier and Lawrence, moved that the proposal be rejected.

On a division vote the motion prevailed, 56 delegates voting in the affirmative and 0 delegates voting in the negative.

Also, "The Committee considered Proposal No. 131, "Article II, Of Suffrage."

"The Committee on Elections and Right to Vote did not recommend the adoption. On a division vote a motion to recommend rejection of the proposal prevailed."

Mr. Kagan, seconded by Messrs. Bizier, Cote, Lawrence and Foster, moved that the proposal be rejected.

On a division vote the motion prevailed, 52 delegates voting in the affirmative and 4 delegates voting in the negative.

Also, "The Committee considered Proposal No. 120, "Suffrage."

"The Committee on Elections and Right to Vote did not recommend the adoption. On a division vote a motion to recommend adoption of the proposal prevailed."

The proposal was referred to the Committee on Style and Drafting.

Also, "The Committee considered Proposal No. 179, "Suffrage."

"The Committee on Elections and Right to Vote did not recommend the adoption of the proposal. On a division vote a motion to recommend the adoption of the proposal prevailed. On April 4th, the day on which the Committee next met, a motion to reconsider Proposal No. 179 was adopted

on a voice vote. A motion to recommend rejection of Proposal No. 179 prevailed on a division vote."

Mr. DiLuglio, seconded by Mr. Canna, moved that the proposal be adopted.

The proposal was read.

On a division vote the motion did not prevail, 26 delegates voting in the affirmative and 40 delegates voting in the negative.

Also, "The Committee considered Proposal No. 188, "Municipal Elections."

"The Committee on Elections and Right to Vote did not recommend the adoption of the proposal. On a division vote a motion to recommend rejection of the proposal prevailed."

Mr. Kagan, seconded by Messrs. Cote and Lawrence, moved that the proposal be rejected.

On a division vote the motion prevailed, 60 delegates voting in the affirmative and 0 delegates voting in the negative.

Also, "The Committee considered Proposal No. 181, "Suffrage."

"The Committee on Elections and Right to Vote did not recommend the adoption of the proposal. On a division vote a motion to recommend rejection of the proposal prevailed."

"On April 4th, the day on which the Committee of the Whole next met, a motion to reconsider Proposal No. 181, "Suffrage" failed on a division vote."

Mr. Kagan, seconded by Messrs. Foster, Cote and Lawrence moved that the proposal be rejected.

On a division vote the motion prevailed, 52 delegates voting in the affirmative and 13 delegates voting in the negative.

GENERAL ORDERS

Mr. Doris, seconded by Messrs. Foster, Kagan and Principe, moved that the Convention resolve into a Committee of the Whole.

The motion prevailed on a voice vote.

Upon the rising of the Committee of the Whole, the Chairman again called the Convention to order.

Upon the resolving of the Convention into a Committee of the Whole, the Chairman called the Committee of the Whole to order.

RECONSIDERATION

Mr. Doris, seconded by Messrs. Lawrence, Kagan and Bizier, moved that the Committee of the Whole reconsider Proposal No. 20-Substitute B, for which a motion to recommend adoption did not prevail at the previous session of the Committee of the Whole.

The General Officers and all members of the General Assembly shall be elected at a general election on the Tuesday next after the first Monday in November every four years commencing in the next even-numbered year nonconcurrent with apresidential election, and shall severally hold their offices for four years from the first Tuesday after the first Monday in January next succeeding their election and until their successors are elected and qualified."

The motion was debated.

Mr. Gorham, seconded by Mr. Pickard, offered the following written motion to amend:

"I move to amend Proposal No. 20, Substitute B as previously amended so as to read as follows:

The General Officers shall severally hold their offices for four years from the first Tuesday after the first Monday in January next succeeding their election and until their successors are elected and qualified."

The motion was debated.

On a division vote the motion to amend did not prevail, 16 delegates voting in the affirmative and 39 delegates voting in the negative.

The motion to recommend adoption was debated.

On a divison vote the motion to recommend adoption of Proposal No. 20-Substitute B, as amended, prevailed, 37 delegates voting in the affirmative and 33 delegates voting in the negative.

Mr. Cooney, seconded by Messrs. Lawrence and Bizier, moved that the Committee of the Whole rise.
