October 3, 1966

The Convention was called to order by Mr. Dennis J. Roberts, Chairman, at 2:16 P.M.

INVOCATION

The Chairman presented Reverend Aaron Usher, Vicar of St. Thomas Episcopal Church, Providence, for the purpose of giving the Invocation. The Invocation was given.

The roll of delegates was called; there were 83 present and 17 absent.

Absentees were Mr. Appolonia, Mrs. Barber, Messrs. Cannon, DeCiantis, DiLuglio, Dodge, Fanning of Cumberland, Gammino, Jordan, Mrs. Lacroix, Mr. Lallo, Mrs. Lambros, Messrs. McCabe, Moon, Parrillo, Smart and Viall.

The names of the absentees were called.

On motion of Mr. Ricci, the delegates extended a rising vote of appreciation to Reverend Usher for his kindness in giving the Invocation.

On motion of Mr. Wexler, seconded by Mr. Principe, the reading of the Journal of the previous day was dispensed, on a voice vote.
