April 12, 1965

The Convention was called to order by Mr. Dennis J. Roberts, Chairman, at 2:20 P.M.

INVOCATION

The Chairman presented Rev. Gordon J. Stenning of St. Mary's Episcopal Church of Providence, for the purpose of giving the Invocation. The Invocation was given.

The roll of delegates was called; there were 74 present, 25 absent. A quorum was present.

Absentees were Messrs. Appolonia, Bacari, Beauchemin, Bissonnette, Champion, DeCiantis, DiLuglio, Dodge, Gallagher, Gallogly, Giguere, Jordan, Kenyon, Kiernan, Lallo, LaSalle, Macari, Manning, Martin, McCabe, Merolla, Moon, Murphy of Coventry, Prince and Sherry.

The names of the absentees were called.

On suggestion of Mr. Dolbashian, the delegates extended Rev. Stenning a unanimous rising vote of appreciation for his kindness in giving the Invocation.

On motion of Mr. Cochran, seconded by Messrs. Bevilacqua, Kagan and Chaharyn, the reading of the journal of the previous day was dispensed on a voice vote.

Mrs. Pulner for the Committee on Executive Department reported back a notification that the Committee, in compliance with Rule 64, will hold a public hearing, April 12, 1965, at 8:00 P.M. at Convention Headquarters on Proposals No. 10, 11 and 23 and that advertisement of said hearing, a copy of which was attached to the report, was made in the Providence Evening Bulletin, April 5, 1965, and in the Providence Journal, April 6, 1965.

By unanimous consent, the report was accepted.
