JOURNAL OF THE CONSTITUTIONAL CONVENTION

Providence, Rhode Island April 26, 1965

The Convention was called to order by Mr. Dennis J. Roberts, Chairman, at 2:19 P.M.

INVOCATION

The Chairman presented Canon Anthony R. Parshley, Retired, of the Diocese of Rhode Island, for the purpose of giving the Invocation. The Invocation was given.

The roll of delegates was called; there were 74 present, 25 absent. A quorum was present.

The names of the absentees were called.

On motion of Mr. Dolbashian, seconded by Mr. Cochran, the Journal of the previous day was corrected to identify Rev. Gordon J. Stenning of St. Mary's Episcopal Church of Portsmouth, instead of Providence, and the reading of the Journal of the previous day, as corrected, was dispensed on a voice vote.

On motion of Mr. Murray, seconded by Mr. Matzner, Resolution No. 16 was ordered to be duplicated and distributed to the delegates before the next session of the Convention on a voice vote.

On suggestion of Mr. Cochran, the delegates extended Canon Parshley a rising vote of appreciation for his kindness in giving the Invocation.

At 2:44 P.M., on motion of Mr. Cannon, seconded by Mr. Cochran, the Convention adjourned to meet on Monday, May 10, 1965, at 2:00 P.M. in the Chamber of the House of Representatives at the State House on a voice vote.
